Findings of Academic Program Review Utilize Peer Comparisons at the Disciplinary Level

In defining the role of an external reviewer for academic programs, the *Handbook for Program Review* specifies a focus on peer comparisons as being central in assessing a department. It states that the Program Review Committee looks to the external reviewer to make the following key comparisons:

- to compare the program under review with departments in other universities that have a similar mission, demographic profile, and funding base; and
- provide a critique of how the program being reviewed is measured in relation to those departments that have reached a higher level of excellence, i.e. aspirational peers.

"The external consultant's role is to serve as a content expert in the discipline being reviewed. The other committee members turn to the external consultant for information about current trends in the discipline and opportunities for external funding."

Delaware Study: A National Study of Instructional Cost and Productivity, Fall 2005

The Delaware Study grew out of FIPSE and TIAA-CREF research grants in 1992 to support the development of national data-sharing consortiums. Over the years more than 400 institutions, both public and private, from all Carnegie institutions have participated in the study. The study has focused on instructional costs and productivity at the level of analysis of academic disciplines. The concept of creating benchmarks by discipline is accomplished by grouping faculty and the student credit hours (SCH) they produce by CIP codes. Initially the study attempted to create benchmarks for quantitative aspects of instructional activity like faculty teaching loads, direct instructional costs and student faculty ratios by discipline. In recent years the study has been expanded to include measures of scholarly and out-of-classroom activities as well.

CSU last participated in this study in Fall 2005. The following Research Universities also participated in the same year and were used to develop peer comparison groups by disciplines (CIP codes). Not all institutions in the following table had CSU's mix of academic programs; therefore, each CSU discipline was compared to a smaller number of peer institutions from the list. For example, fewer than 10 institutions had Urban programs that could be used for comparison purposes.
